Summary of Superintendent Search Options/Procedures & Possible Action

David Cunningham, director, human resources and legal services, reported that since the regular meeting of the Board of Education on November 23, 2015 when Dr. Rick Doll resigned as superintendent of schools, he contacted five executive firms in regard to conducting a search to identify and hire the next superintendent.

Mr. Cunningham reported that he had received proposals from four firms including McPherson & Jacobson, Ray and Associates, Kansas Association of School Boards, and School Exec Connect. He outlined the phases/stages through which each would progress.

Anna Stubblefield, director, human resources, reported on the process the district would use should the board decide to keep the superintendent search in-house.
