MOTION FOR EXECUTIVE SESSION

At 6 p.m., Board President Marcel Harmon called to order a meeting of the Board of Education for the purpose of entering executive session. Rick Ingram made a motion, seconded by Shannon Kimball, to recess to executive session to discuss personnel matters of non-elected personnel in order to protect the privacy interests of the individual to be discussed, with Kyle Hayden, superintendent, invited to be present, and with the board to return to open session in this room at 6:55 p.m. The motion passed by a unanimous voice vote.

At 6:55 p.m., the board returned to open session where Board President Marcel Harmon declared a break until the start of the regular meeting.

CALL TO ORDER REGULAR MEETING

At 7 p.m., Board President Marcel Harmon called to order the regular meeting of the Board of Education.

APPROVAL OF AMENDED AGENDA

SPECIAL RECOGNITION OF STUDENTS, STAFF & COMMUNITY PARTNERS

Boys & Girls Club Youth of the Year - Zion Bowlin

Colby Wilson, executive director, Boys & Girls Club of Lawrence, stated that the Youth of the Year is the Boys & Girls Club's premier recognition program honoring young people who have overcome obstacles, possess great character, give back to their communities and set great life goals. He introduced *Zion Bowlin*, senior, Free State High School, as the 2017 Boys & Girls Club of Lawrence Youth of the Year.

REPORT OF PRESIDENT OF BOARD OF EDUCATION

Board President Marcel Harmon thanked those who participated in the Community Conversation about Racial Equity in Lawrence Public Schools on January 30. He reported that staff is compiling and summarizing data received that evening and a board work session has been scheduled for 5 p.m. on Monday, February 27, where the information will be shared and discussed. He noted that the information will also be shared with the community.

REPORT OF SUPERINTENDENT OF SCHOOLS

• Superintendent Kyle Hayden stated that he has been working on a reorganization of existing personnel to improve support for the district's equity work, professional development of teaching staff and the success of all students. He reported that Assistant Superintendent of Educational Support Anna Stubblefield will add to her supervision of human resources, oversight of the district's equity work, effective immediately. He said she will work with administration and staff to develop strategies to meet district equity goals to provide professional development related to culturally relevant teaching, continue Beyond Diversity training for all district staff, expand student equity leadership development and develop partnerships for student success through continued engagement of school families and community members and organizations. Mr. Hayden reported that he also plans to create an assistant director of teaching and learning position to directly support teacher training and student achievement, saying that South Middle School Principal Jennifer Bessolo will transfer

into this new position, effective July 1, 2017. He said she will join Assistant Director of Curriculum, Instruction and Assessment Kirsten Wondra in supervising learning coaches. Mr. Hayden noted that the district will immediately begin a search for a new principal for South Middle School. He also stated his plan to combine the district's curriculum facilitators with learning coaches to maximize the impact of the coaching team and provide school-based training for culturally relevant teaching and personalized student learning. He said he approached this as a cost-neutral change, but it actually will carry a slight cost savings due to eliminating the unfilled administrative support positions and combining curriculum facilitators with our learning coaches.

- Mr. Hayden stated that he has instructed schools to invite parents of students of color to submit applications to serve on the newly-formed District Equity Leadership Team Advisory Council. In addition, he said that those who expressed an interest at the Community Conversation event in serving on the committee will receive information about applying.
- Superintendent Hayden extended congratulations to the district's U.S. Presidential Scholars Program Candidates from Free State High School: Natalie Adams-Menendez, Charlotte B. Crandall, Sayuj S. Thapa, Helen E. Weis and Adelaide Wendel.
- He reported that the Free State Scholars Bowl team won the State Championship this past weekend in Derby.
- Mr. Hayden announced that there will be no school for elementary and middle school students on Friday, February 17, due to recording and reporting of student progress at the elementary level and a middle school professional development day.

REPORTS

<u>Learning Forward, Future Ready Update & High School Recommendation</u>

Jerri Kemble, assistant superintendent, innovation and technology, introduced Jana Hare and Amber Rowland from KU's Center for Research on Learning (ALTEC) who shared the results of surveys and focus group meetings conducted to evaluate the semester-long pilot project involving Free State High School and Lawrence High School

to determine the preference between the iPad and MacBook Air Laptop Computer as the 1:1 device to be recommended for students. It was reported that surveys taken by teachers, students and parents, as well as comments made during the group meetings indicated that the MacBook Air is the preferred device.

Ms. Kemble recalled the process followed by the district's Digital Learning Task Force to design and implement the high school pilot project. Members of the task force including Aimee McLendon, social studies teacher, Free State High School; Chris Johnson, social studies teacher, Lawrence High School; and Oather Strawderman, science department chair and physics teacher, Free State High School; reported on their experiences utilizing both the iPad and MacBook Air in the classroom that reinforces their recommendations for the MacBook Air as the preference for the 1:1 device.

It was reported that 19 out of 26 members (73.1%) of the Digital Learning Task Force ranked the MacBook Air as their first preference for the 1:1 device. Ms. Kemble stated that a request for approval for 1:1 MacBooks for high school students beginning in the 2017-2018 school year will come before the Board of Education at an upcoming board meeting.

Ci3T Student System of Supports

Leah Wisdom, assistant director, student services, presented a general overview of the district's Comprehensive Integrated Three-Tiered (Ci3T) Model of Prevention to address the various needs of students in academic, behavioral and social areas. She noted that the supports are proactive, preventative, and data-informed, and are used simultaneously.

Examples of ways in which Ci3T is being institutionalized in USD 497 schools were reported by Bill DeWitt, assistant principal, Lawrence High School, and Tammy Becker, principal, Hillcrest Elementary School. It was reported that each building Ci3T leadership team, made up of the principal, teachers, parents and students, works together to craft its plan through soliciting feedback from stakeholders, then communicating and integrating the feedback into the plan. In addition, the team strategizes how Ci3T will be taught, reinforced and monitored.

Ms. Wisdom reported that forward progress will include integration into the system for new staff and principals, monitoring the communication structure, enhancement of implementation of culturally relevant teaching and consideration of multiple sources of data.

Update on May 2 Bond Election

Julie Boyle, director, communications, reported on ways USD 497 plans to engage the community and provide information in regard to the May 2, 2017, Lawrence School Bond Mail-Ballot Election.

She highlighted the information that needs to be shared including the district's successful 2013 bond issue, and the process followed to determine the scope, budget and projects at the middle and high schools in the current referendum. She stated that the community also needs to know the goals to 1) provide flexible spaces to enhance students' educational experiences and opportunities to collaborate, create and innovate; 2) address equity across school facilities; 3) improve safety and security; 4) accommodate growth; and 5) deliver energy efficient, high-performance schools that

promote student and staff wellness and success. Other information that needs to be shared is in regard to the district's financial position and the impact to community members. Ms. Boyle stated that it is important too for the community to be informed about the ballot language, the election timeline and voting instructions.

Also highlighted were a number of ways information will be disseminated to district administration and staff, students, parents and community members including group presentations, distribution of fact sheets, direct mailers to registered voters, newspaper inserts, local media, social media, and a variety of other avenues.

REPORTS AND APPROVALS

<u>Approval of Board Policy Committee Recommendation for Board Governance & Operation Procedures</u>

Shannon Kimball, board vice president and board policy committee member, reported that the board's policy committee has met and discussed the possibility of Lawrence Public Schools adopting governance and operating procedures to guide the work of the Board of Education. She presented a template from another Kansas school district and asked for engagement from board members around the benefits of this concept.

Vanessa Sanburn, board member and board policy committee member, stated that this seems to flow well from the training the board received from the Kansas Association of School Boards at its January 23, 2017 professional development work session. She said she thought it would provide greater clarity to some of the operating procedures and would be good for new members to the Board of Education.

Ms. Kimball stated that any board member interested in serving on a committee to draft the document should let Board President Harmon know. She said the timeline for completion is the end of the current fiscal year so that the document can be adopted as part of the organizational meeting in July and every year after that.

Following a brief discussion where there was agreement around the concept, a motion was made by Rick Ingram, seconded by Jessica Beeson, to approve the appointment of an *ad hoc* committee to develop board governance and operating procedures for further consideration and possible adoption at a future meeting. The motion passed by a unanimous voice vote.

Acceptance of Resignation of Board Member Kris Adair

Marcel Harmon, president, board of education, recalled that Board Member Kris Adair submitted a letter of resignation from the board on February 10, 2017, noting that her term is scheduled to expire on January 8, 2018.

Board President Harmon recognized a patron who wished to speak.

Peter Karman, parent, encouraged board members to fill the seat with a person of color to better reflect the diversity of colors of our community.

Mr. Harmon suggested a timeline, should the board vote to accept the resignation that included the following:

- February 13: Acceptance of resignation of Kris Adair
- February 15: Vacancy notice published in Lawrence Journal-World and application made available on USD 497 website

- March 6: Deadline for submission of applications
- March 7-12: Board review of applications
- March 13: Board discussion of applicants and appointment of new board member to fill vacancy

Vanessa Sanburn suggested that it would be good to solicit applications from members of the community who have shown interest in serving on the District Equity Leadership Team Advisory Council.

Board Vice President Shannon Kimball stated that Kris Adair's lack of participation recently and last year during the superintendent search was difficult for the board. She said she was dismayed that Kris chose to use her letter of resignation to disparage the board and make unfounded allegations in regard to decisions made by the board. Ms. Kimball said she is glad to have the opportunity to find a person who will share the time, dedication and enthusiasm to commit and be a successful member of the board.

Following a motion by Vanessa Sanburn, seconded by Jessica Beeson, the board voted, in a 6-0 roll call vote, to accept the resignation of Board Member Kris Adair and direct that the application to fill the term until January 8, 2018 be made available to the public on Wednesday, February 15, 2017.
