Re: Contract with *SchoolDude* for Facilities & Operations Software

Date: February 4, 2016

Background:

In 2008, facility usage management software was purchased to efficiently book facility space as needed in a quick manner while improving the facility scheduling process. The Facilities and Operations Department (F&O) also purchased a work order software to create time and cost savings through streamlining the process of scheduling reactive and preventative maintenance, tracking inventory usage, responding to critical system alarms and planning future capital needs. Because of the improved efficiency with the above mentioned software, F&O would like to renew and upgrade its services to an improved software platform. The improved platform will have an interactive calendar for facility use that will be beneficial to Lawrence Public Schools and our outside user groups.

Once the upgrade is approved, *SchoolDude* will allow Lawrence Public Schools to use the upgraded platform through 6/30/2016 at no extra cost. The pricing below is for a one year contract from 7/1/2016 to 6/30/2017 and has been procured through the Greenbush SKESC purchasing cooperative.
