## Background:

During the 1999-2000 school year, Lawrence Public Schools changed to a bid process for band and orchestra instrument repairs. This was done to bring a more consistent repair process to the district. Since 2002-2003, the district has separated the contracts for brass/percussion, woodwind and orchestra for the bid process.

## Rationale:

Due to timing and staffing issues of previous contracts and a continued aging inventory of instruments, it was determined a repair/maintenance combined contract that starts earlier was needed. The addition of cleaning and maintenance into the repair contracts will benefit the inventory of instruments long-term. Along with this earlier bid process, a new vendor evaluation rubric was created to help choose the vendor that best fits district needs instead of relying only upon price.

On March 28, 2016, bids were sent to nine (9) vendors with a bid opening on April 15, 2016 at 2 p.m. The results of the bids using the vendor evaluation rubric are as follow:

## Recommendation:

Administration recommends that the Board of Education accept the BEAUTIFUL MUSIC repair/maintenance contract in the amount of \$15,000 for orchestra instruments, WIND INSTRUMENT CONNECTIONS repair/maintenance contract in the amount of \$36,100 for woodwind instruments and BAC MUSIC repair/maintenance contract in the amount of \$45,540 for brass/percussion instruments. The total amount for all three contracts is \$96,640.

Payments will be made on a payment schedule per the bid specifications as follows:

- 50% of the contract within 30 days of executing the agreement
  - 25% on or about January 1, 2017
  - 25% at the conclusion of the agreement, May 1, 2017 or upon completion of all vendor obligations as determined by district.

The contract will be paid from the Teaching and Learning budget and existing instrument rent/maintenance fees collected from students.

## Motion:

"I move the Board of Education approve contracts with Beautiful Music (\$15,000), BAC Music (\$45,540), and Wind Instrument Connections (\$36,100) for band and orchestra instrument maintenance and repair from May 2, 2016 - May 1, 2017 for the total amount of \$96,640, following a scheduled payment plan and with quarterly performance evaluations of the vendor to ensure contract compliance."
