Re: Renewal of Casper Suite Management Software

Background:

Since the 2013-2014 school year, the Lawrence Public Schools has continued to deploy mobile devices to teachers, staff and students in order to support additional roll out of blended classrooms, the iPad Initiative and continued progression toward personalized learning for students. A majority of those devices have been Apple products that include Casper Suite Management Software from JAMF Software, LLC.

Board of Education Goal 1: Continue to evaluate and expand personalized learning through blended environments with emphasis on: instructional strategies and the use of furniture, space and technology. Communicate to staff that the expectation is that all teachers will transition to personalized learning strategies in a blended environment.

Rationale:

In order to continue using and managing the Apple products in the district, the Casper Suite Management Software would need to be renewed from JAMF Software, LLC. The annual renewal quote is based on the number of devices that are currently enrolled in the management system. As devices are added, specifically for the 1:1 rollout at the middle schools, they will automatically be enrolled at no charge until our next renewal date. JAMF Software, LLC has submitted the annual renewal quote in the amount of \$55,300.

Recommendation:

Administration recommends renewal of the annual Casper Suite Management Software through JAMF Software, LLC to be paid out of Technology General Fund, Software Services (0125800000-54440).
