Background:

Beginning with the 2007-2008 school year, Lawrence Public Schools chose Skyward as its Student Information System (SIS). There has been continued expansion of the use of Skyward, including the implementation of the Parent Access module.

Rationale:

As with all large software packages, it is necessary to pay annual maintenance in order to continue to receive product support and upgrades. For the 2016-2017 school year, the annual Skyward License Fee is \$102,686.

Recommendation:

Administration recommends renewal of the Skyward License Fee to be paid out of the Technology general fund for Software Services (0125800000-54440).
