President Commentary

President Shannon Kimball shared with the board members regarding the upgraded technology in the board room that if they are talking into the microphone and it sounded muffled that they were too close and would need to sit back.

President Kimball thanked Kathy Johnson, executive director of finance, for all her hard work in order to be prepared for today's meeting, as she had only recently received the state budget forms. In addition, President Kimball announced that the floor would be open for public comment after Mrs. Johnson's budget report.

Reports & Approvals~

Kathy Johnson, executive director of finance, provided information regarding the 2017-18 budget. The information is being shared now in order to be approved for publication. The district is required to publish the budget 10 days in advance of a public budget hearing and final approval. As such, there is another Special Board Meeting planned for 5:30 p.m. on August 22, 2017, for the public budget hearing and budget approval. The budget must be certified with the county and Kansas State Department of Education (KSDE) by August 25, 2017.

The 2017-2018 budget will be built based on the prior fiscal year's audited enrollment, with Kindergarten students counted as 1.0 FTE instead of .50 FTE for funding. The current Base State Aid Per Pupil is \$4,006.

Mrs. Johnson reviewed the fund types that comprise the budget-

The budget reflects a tax increase of 3.5 mills. A mill is \$1 of taxes for every \$1,000 of assessed value of property. After three years of flat funding under the state's block-grant system, the Kansas Legislature approved a change in the school finance formula, Senate Bill 19, causing a 1.2 million loss in state aid and a corresponding spike in Local Option Budget authority requiring a 2.3 mill increase in local revenue.

The remaining 1.2 mill increase is the result of a district decision to sell this year only half of the bonds approved by voters in May for \$87 million in secondary school facility improvements. By waiting to sell the other half of the bonds in 2018-19, when the remaining funds will be needed for school construction, the board can reduce the tax impact to its Bond and Interest Fund from an estimated 2.4 mills to 1.2 mills this year.

With the new formula, USD 497 is scheduled to receive \$\$6,170,637 in new revenue. The board has tentatively approved net additions and budget expenditures in the amount of \$6,080,741 to use for professional development, classified market study implementation, certified staffing, ESL FTE, contingency at elementary and middle school, Farm 2 school garden programs, instructional resources, technology-licensing/professional services, COLA adjustment and internet/utility usage.

Mrs. Johnson also shared that school districts must budget "high" for authority, and cannot spend more than the published amount, even if there are revenues that would allow the district to exceed it. To exceed the maximum authority, the budget would have to be republished, and in some cases, certain levied funds cannot be republished. If a published budget authority is exceeded, beyond any reimbursement income, it is a statutory violation and is a financial red flag when agencies such as Moody's review audited financials for bond ratings. Form Code 99 sets the maximum budget authority and maximum mill levy.

Mrs. Johnson reviewed the funds and provided the 2017-18 General Fund and LOB Legal Max as follows-

Upon a motion by Vanessa Sanburn, seconded by Jessica Beeson, the board voted, in a 6-0 roll call vote, to approve publication of the legal maximum authority of \$101,285,374 for the 2017-18 budget as proposed. Thus, establishing the maximum amount of taxes to be levied at 56.863 mills.

PATRON COMMENTARY
