SPECIAL RECOGNITION OF STUDENTS, STAFF AND COMMUNITY PARTNERS

<u>West Middle School Future City Regional Champions</u> Principal Brad Kempf

Principal Kempf introduced Charla Keefer, gifted education facilitator, and Wilson Kilmer, social studies teacher, who recognized their students who were recently named the Future City Regional Champions in the Great Plains Regional engineering competition at Kansas University. This group placed 3rd last year in the Regionals and was determined to come back this year and win it all. The students provided the entire board with winning buttons from the Regional Championship.

REPORT OF PRESIDENT OF BOARD OF EDCATION

- Resident Kimball shared that since our January 22 regular meeting, the board has held 3 special meetings to complete the hiring process for our new superintendent. "I want to say congratulations and welcome again to Dr. Anthony Lewis. We are looking forward to working with him, and the board and staff are already working on the transition process in preparation for Dr. Lewis's July 1 start date."
- On January 26, in her capacity as president-elect designee of KASB, President Kimball attended a special meeting of the KS SBOE that was called in response to concerns raised by Senator Susan Wagle and Representative Ron Ryckman

regarding KSDE's handling of transportation funding under the school finance formula. She was glad to report that the SBOE gave direction to Education Commissioner Randy Watson to support the KSDE staffs' handling of the matter, but to also come back to the SBOE with an information plan to enhance transparency around the funding formula. Of note, that issue has sparked further discussion about areas where the legislature has chosen not to follow state statute in funding schools. KASB has put together data showing that, since 2009, the legislature has not appropriated \$867 million dollars to which school districts were entitled by the language of state statute. This is important context in the discussion of funding adequacy and equity.

- On January 31, President Kimball attended the Partnership for Early Success Early Childhood Symposium in Topeka. The symposium's speakers focused on the opportunity gap for children in early learning, especially minority children, and how that opportunity gap impacts student outcomes throughout K-12, particularly focusing on the question of how our policies as a district, and as a community, impact the gap and/or support access to early childhood education for all. A couple of examples that were given included food insecurity, and whether district policies support early identification of FRL learners; immunizations and well child care/health insurance and how access to appropriate health care impacts student attendance at school, given that chronic absenteeism is a warning sign regarding future success (e.g., in Kansas our childhood uninsured rate is 5%, national average is lower at 4% ...).
- Also as part of her service with KASB, President Kimball had the great opportunity last week to attend the NSBA Advocacy Institute in Washington, DC. Theyspent two days in learning opportunities, and then a full day visiting the congressional delegation on Capitol Hill. She was part of the team that met with Senator Moran, Congresswoman Lynn Jenkins, and Congressman Roger Marshall. President Kimball was able to share with them stories about LPS USD 497 as it related to issues of school choice, and federal appropriations for Carl Perkins, Title programs, and special education funding. She appreciated their willingness to listen to our concerns, and is hopeful that our advocacy made an impact with regard to their thinking on those issues.
- President Kimball acknowledged that the board competed Dr. Stubblefield's evaluation earlier in the evening. While she was unable to share the specifics, she did extend the board's appreciation of the excellent work Dr. Stubblefield has done for our district this year.

REPORT OF SUPERINTENDENT OF SCHOOLS

- Superintendent Anna Stubblefield extended her congratulations to our five Presidential Scholar candidates: Graham Edmonds, Quentin Harrington, Jackson Hoy and William Kampa, all of Lawrence High, and Janet M. Stefanov of Free State High.
- Superintendent Stubblefield thanked the Lied Center for partnering with us to bring Scott Turner Schofield, an acclaimed diversity educator on transgender issues and a transgender actor, to our district last week for discussions with staff and high school students. He also presented public programs at the Lawrence Public Library and the Lied Center.
- Superintendent reminded our elementary families that there is no school for grades PreK-5 on Friday due to Recording and Reporting of Student Progress in advance of parent-teacher conferences next week.

• Lastly, Superintendent Stubblefield also reminded our board members that the school board lunch tomorrow is at Woodlawn at 11am.

President Kimball asked for patron comment on any item not included on the agenda.

REPORTS

<u>AVID</u>

Leah Wisdom, assistant director, equity and student support services, shared the history of the AVID program in the district.

The Lawrence Board of Education approved the AVID program in 2012 for Free State and Lawrence High Schools. In 2013-14, the board expanded it to the district's four middle schools. Since that time, enrollment in the AVID elective has grown from 44 to 337 students. Buildings are also using the AVID strategies school wide.

AVID uses a structured approach and evidence-based practices to assist students in being successful in rigorous curriculum. The program accelerates student learning and supports academic and social skills with a system that values goal setting, leadership and a culture of collaboration and personal achievement. AVID students typically perform in the academic middle, but are highly motivated and college-bound. Some become the first in their family to attend college. AVID's mission is to close achievement gaps by preparing students for college readiness.

3 students, Akia Miles (LHS), Jessica Merritt (FSHS) and Genevieve Gilbert-Cavender (FSHS) shared how being involved in the AVID program has been beneficial to them.
