SPECIAL RECOGNITION

Finalist for Kansas Teacher of the Year – Lucinda Crenshaw

Dr. Rick Doll, superintendent, acknowledged Lucinda Crenshaw, seventh grade science teacher at West Middle School, who has been named a state finalist for Kansas Teacher of the Year. He noted that Lucinda, a nationally board certified teacher, earned her bachelor's degree at Southwestern College and her master's at Wichita State University. She taught four years at the elementary level in Langdon, Turon and Kansas City, Kansas. After joining the Lawrence school district, she taught 11 years at Deerfield Elementary School and is in her 16th year at West Middle School.

Dr. Doll read the words of Myron Melton, principal, West Middle School, which said that *Lucinda's passion for teaching and learning has impacted every aspect of the West community. Her planning, preparation and attention to detail are impeccable. Her students are routinely exposed to learning opportunities that are engaging, relevant and challenging. She stretches students to become problem solvers and collaborators, and helps them make connections to real-world applications.*

Special Recognition ~ Lucinda Crenshaw (Continued)

It was reported that Lucinda has provided leadership to Lawrence Public Schools as president of the Lawrence Education Association in 1997 and through her work with negotiations, collaboration, evaluation, science leadership and the district's transition to middle schools.

The Kansas State Department of Education will host a recognition banquet on November 21 in Wichita where the 2015 Kansas Teacher of the Year will be named. In 1983, Patricia Williams Boyd, a music teacher at then-Central Junior High, was named Kansas Teacher of the Year.

REPORT OF BOARD PRESIDENT VANESSA SANBURN

There was no report.

REPORT OF SUPERINTENDENT RICK DOLL

- Superintendent Rick Doll expressed appreciation to the middle and high school parents who participated last week in Parent-Teacher Conferences. He stated that the opportunity to continue to engage parents in their children's education is valued.
- Superintendent Doll reported that he continues to meet with students and staff around the board goal to investigate issues related to LGBT students. He said this has opened a good dialogue about how the district can best support all students in feeling welcome and accepted at school.
- He reported that, following an invitation by Gould Evan Architects, he attended last week a conference of the Council of Educational Facility Planners International, where he helped to present information about how the district has worked with our architects during bond issue construction to transform our school libraries, as part of the larger learning environment. He stated that school libraries are evolving from book depositories to learning incubators, research hubs, maker spaces and places for community and social learning.
- Dr. Doll stated that the district's work around its Excellence, Equity and Engagement Goals has drawn the attention of the University of Kansas School of Special Education. He reported that KU will present its 2015 Whelan Kansas Leadership Award to the district on Thursday for our focus on improving learning opportunities for all students. He said that Angelique Nedved, Terry McEwen, Kevin Harrell and Leah Wisdom will be recognized and will make a short presentation about our blended learning, equity and CI3T work.
- He stated that he had planned to be a part of the Whelan Award presentation on Thursday, but has been invited to attend a national Open Education Symposium this week at the White House. He reported that the U.S. Department of Education's Office of Educational Technology has asked him to participate in a discussion of our blended learning initiative, use of digital resources, and specifically, our use of openly licensed educational resources, which the Teachers on Special Assignment (TOSAs) have been identifying, as part of their work to build course masters to support our teachers.
- Dr. Doll stated that there are a lot of great things happening in our district and it is nice to see some external acknowledgement of our work.

BOARD COMMENTARY

Marcel Harmon

...reported that the City of Lawrence is looking for some letters of support from the community in regard to grant applications for the Safe Routes to School program and expansion of the Burroughs Creek Trail. He said he thought it would be good for the board to submit a letter for the Safe Routes to School program, and expressed his willingness to write it.

REPORTS

BusinessPLUS Development

Kathy Johnson, director, finance, and Susan Fowler, supervisor, human resources, payroll and benefits, described and demonstrated BusinessPLUS, the district's financial and human resources information management software, acquired as part of the 2005 bond issue.

It was reported that BusinessPLUS has components that help manage the district's \$151 Million budget; process \$98 Million in annual employee wages, benefits and related employer costs; manage the recruitment, hiring and staffing process for over 2,000 employees; and purchase supplies, equipment, services, capital improvement, etc., that support and impact 11,716 students on a daily basis.

Ms. Johnson reported that the software will also help in meeting 2015-2016 Board of Education goals in the areas of best practices for certified evaluation and quality services through integrated management systems.

Update on School Traffic and Crosswalk Changes

Ron May, director, administrative services, reported on the process that has been developed by the City of Lawrence, in cooperation with Lawrence Public Schools, to address concerns expressed by the community in regard to traffic flow and crossings that impact schools.

Mr. May updated the Board of Education on the following projects/issues:

- Cordley – Evaluation of traffic flow and parking and community meeting
- Kennedy – Change of school crossing and crossing guard location
- Pinckney – Tunnel security camera
- New York – Evaluation of traffic flow and parking
- Broken Arrow/South – Community meeting regarding results of new traffic study
- Sunset Hill – Request for crossing guard at 6th Street and Schwartz Road

Kyle Hayden, assistant superintendent, business and operations, reported on concerns expressed by McCownGordon Construction in regard to safety related to the Pinckney Tunnel while construction projects are being completed at the school through the 2016-2017 school year. He said the main concern deals with pedestrian traffic and the close proximity of the tunnel to the school site, which will be closed. Mr. Hayden said students will not need the tunnel as they will board a bus on both the north and south sides of 6th Street. He said, however, that the tunnel provides access for the entire Pinckney community. It was noted that the decision in regard to the tunnel will not be made by the Board of Education, but by the City of Lawrence.

Board President Vanessa Sanburn acknowledged a patron who wished to speak.

Reports ~ School Traffic & Crosswalk Changes (Continued)

Pat Miller, president, Pinckney Neighborhood Association, stated that safety at the construction site is important, but closing the tunnel will isolate the Pinckney neighborhood from the rest of the city. She noted that 6th Street is busy, and safe crossings at Kentucky Street, Maine Street, and Michigan Street are nearly seven blocks apart. Ms. Miller said it needs to be figured out at what point the tunnel should be closed for construction and at what point it can be kept open.

OLD BUSINESS

There were no items of old business.

NEW BUSINESS**Approval of Commissioning Services Contract with Viridian**

Upon a motion by Shannon Kimball, seconded by Kris Adair, the board voted, in a 6-0 roll call vote, to approve the Commissioning Services Contract with Viridian in the amount of \$162,433 for USD497 Lawrence Public Schools.

Background:

The Board Policy Committee met to discuss several policies that were recommended to the Board of Education for amendment. The recommendations were received on October 26, 2015. No questions or suggested changes were communicated to the policy committee; therefore, the committee recommends the board take final action to amend the following board policies:

CEF Expense Reimbursement and Purchasing Cards

Board Policy CEF is being amended to ensure staff understand rewards points or cash back earned when using district credit cards are considered district property, not the individuals using the card, and will be applied to future purchases or remitted to the district.

DC Annual Budget

Board Policy DC is being amended to conform with the Kansas Uniform Financial Accounting and Reporting Act and the rules and regulations promulgated thereunder. The new section “Budget Transparency” sets forth the requirement to maintain, report, publish and make available to the public specified budgetary records, forms and information.

GAOE Workers Compensation

Board Policy GAOE is being amended to ensure conformity with revisions to the Workers Compensation Act pertaining to notification requirements, use of paid leave, and use of individual providers and add chemical testing provisions related to workers compensation benefits in the event of a work accident.

GAHB Political Activities

Board Policy GAHB is being amended to clarify existing language and combine GAHB, GBRK and GCRK. GBRK and GCRK are recommended for deletion. BBRK and GCRK both address the prohibition of using school time, property or equipment for political purposes. GAHB addresses an employee holding political office. One policy can address the subject matter of each individual policy so it is recommended they be combined.

Recommendation:

The Board Policy Committee recommends the board take final action to amend the referenced policies.

CEF Expense Reimbursement and Purchasing Cards

CEF

1 The use of district motor vehicles and district purchasing cards by the

4 the superintendent. The superintendent shall monitor monthly receipts and re-

2 current statute. The combined workers compensation benefits and salary re-
3 ceived under allowed paid leave shall not exceed one full day's pay.

4 All employees of the district shall be covered by workers compensa-
5 tion. Workers compensation coverage is provided for all employees regardless
6 of assignment, length of assignment, and/or hours worked per day. Benefits
7 are for personal injury from accident or industrial diseases arising out of and
8 in the course of employment in the district.

9 An injured employee must notify the designated employer's workers
10 designated representative or, if the designated representative is unavailable,
11 his or her supervisor within 20 days of the injury or within 20 days of repeti-
12 tive trauma in order to be eligible for benefits.

13 The workers compensation plan will provide coverage for medical ex-
14 penses and wages to the extent required by statute to those employees who
15 qualify; however, the amount of workers compensation benefits and paid leave
16 benefits shall not exceed a regular daily rate of pay. An employee using paid
17 leave—or district paid disability insurance, in combination with workers com-
18 pensation will be charged for one full or partial day of paid leave, as provided
19 for in the sick leave policy or the negotiated agreement, for each day of ab-
20 sence until the employee's sick leave is exhausted.

13 is refused, all workers compensation benefits shall be forfeited by the employ-

15 Choice of Physician

16 The board shall have the right to choose a designated health care pro-
17 vider to provide medical assistance to any employee who suffers an injury

1 while performing their job. However, if the injured employee chooses to go to
2 a medical provider other than the designated provider, the recovery for such
3 expenses shall be limited to \$500.00.

KGE

1 It is prohibited for any person, other than a law enforcement officer, to

4 activities of pupils, or at any regularly scheduled school sponsored activity or
5 event, even if such employee holds a valid concealed carry license. Possession
6 of a weapon in a school vehicle or an employee's personal vehicle being used to
7 transport students is also prohibited, even if such employee holds a valid
8 concealed carry license. The secured storage of a weapon in an employee's
9 personal vehicle on school property, grounds or at a school sponsored event is

Re: 2014-2015 Kansas Assessment Program (KAP) Results

Date: November 5, 2015

Background:

In school year 2014-2015, Kansas administered state assessments in the areas of English Language Arts (ELA) and Mathematics to Grades 3-8 and at Grade 10. In addition, a revised science assessment was administered to Grades 4, 7, and 11. History/Government/Social Studies assessments were field tested at Grades 6, 8, and 11.

The ELA assessment contained reading and writing sections, including a multidisciplinary performance task that required students to read, take notes and then write a response. The Mathematics assessment included a written performance task that asked students to analyze a response or justify their answer to an authentic application of mathematics.

Unlike previous assessments, this computerized test employed technology-enhanced items that required students to do more than pick the right answer from a list. For example, students were required to order items, create categories, label areas, plot graphs and select multiple responses.


The completed assessments underwent multiple educator reviews to establish cut scores and performance levels. The performance levels will be listed as follows: Level 1 (performance is below grade level expectations), Level 2 (the student is at grade level but not yet on track for college or career readiness), Level 3 (the student is at grade level and on track for college or career readiness), and Level 4 (the student exceeds grade level expectations and is on track for college or career readiness).

Additional Information:

The results from the 2014-15 Kansas Assessment Program tests establish a baseline of performance. There is no methodology that allows us to find trends, establish a “meets or not meets” specific performance metrics, or provides information that informs us about progress based on only one administration of the assessments. It will take at least one to two more years for analytics to become more meaningful.

In addition, it is important to note that the four levels of performance represent a learning continuum. While a student may be performing at a Level 1 or a Level 2 in 2014-2015, this does not in any way suggest that the student cannot increase their performance. It is highly likely that in a subsequent year, a student scoring a 1 or 2 could move up one or two levels.

Most important, the Kansas Assessment Program results represent but one score in a specific subject area. These scores represent only how students performed in the first year of a new assessment on a specific day and time. The results do not “label” a student nor do they represent the entirety of what our students know and are able to do. It is only through the administration of multiple assessment measures and analyzing multiple data sources that we are able to truly understand the college and career readiness of our students.

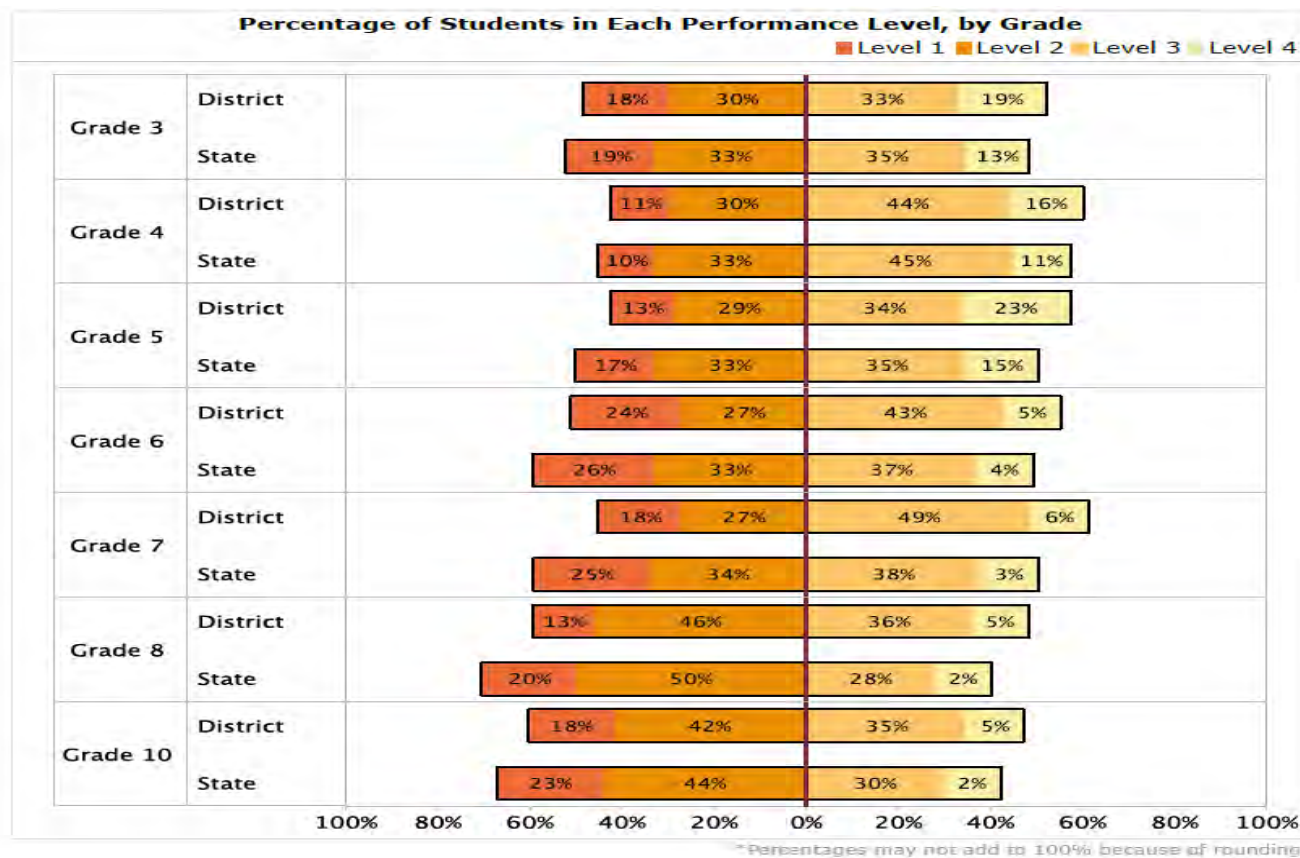

English Language Arts (ELA): Comparison of Grade Level Performance in USD497 to Statewide Grade Level Performance



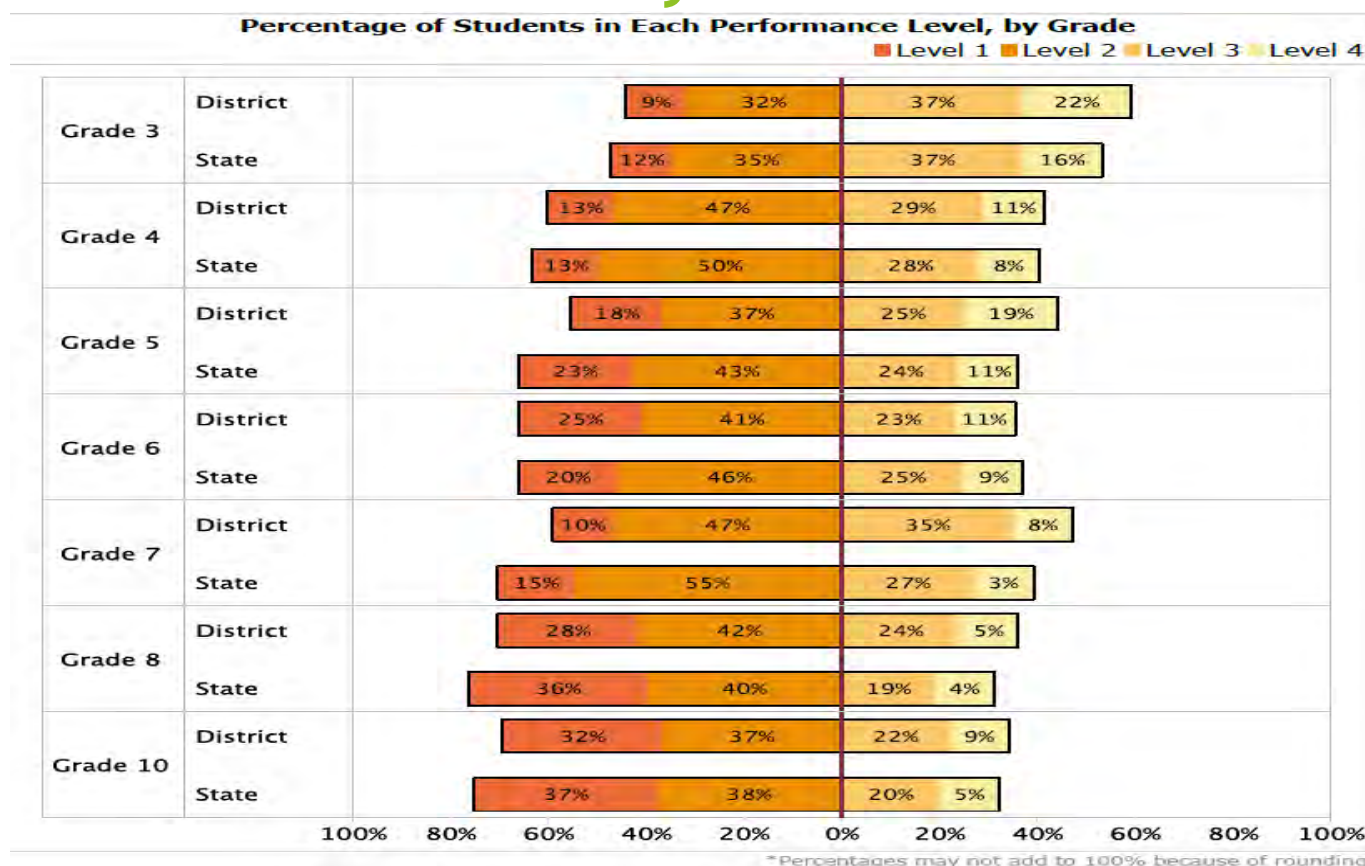
Percentage of Students in Each Performance Level by Grade



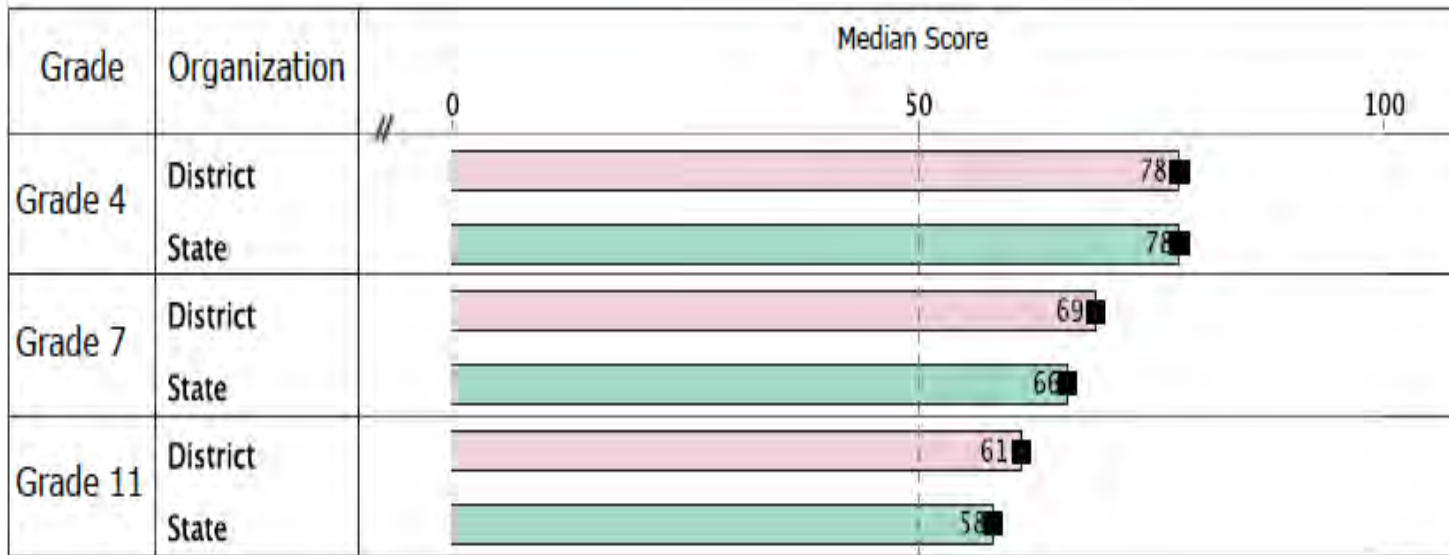
Mathematics: Comparison of Grade Level Performance in USD497 to Statewide Grade Level Performance



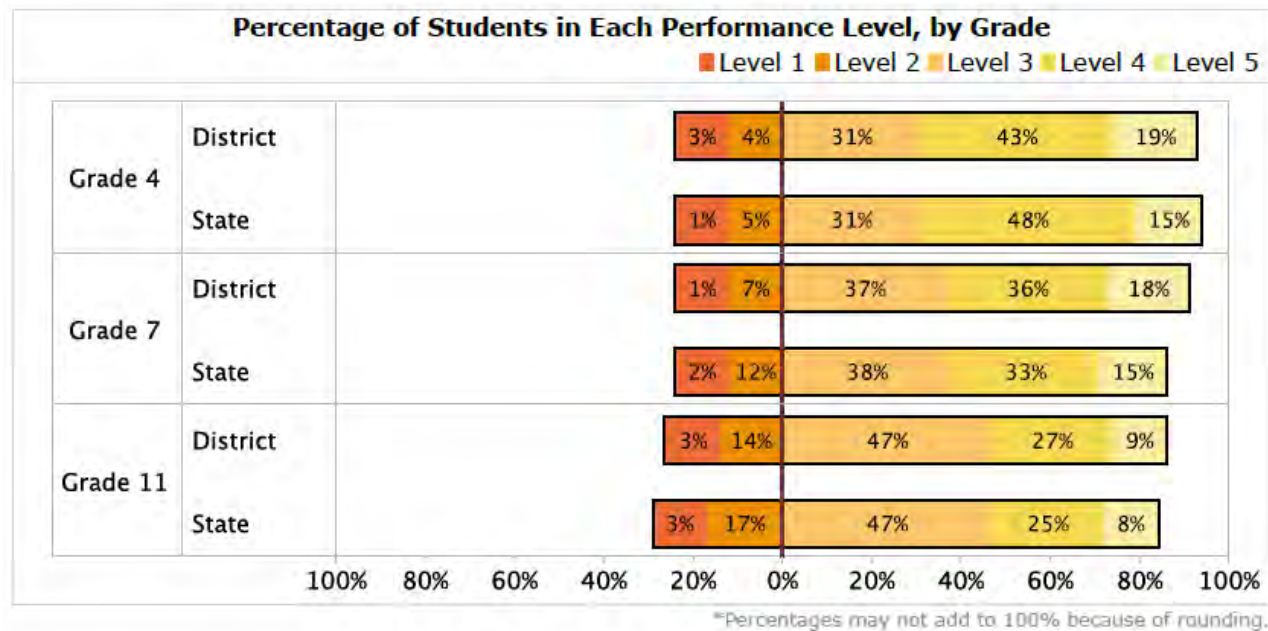
Percentage of Students in Each Performance Level by Grade

Background:

Changes were necessary to the 2016-17 District Calendar to reflect last year's ratified Master Agreement adding two professional development days to elementary and middle school schedules.

With both the 2016-2017 and proposed 2017-2018 calendars, these additional PD days have been scheduled to allow for students across grade levels to be out of school on the same dates.

Proposed Changes:

For the 2016-2017 revised calendar, we are recommending that the elementary PD days be scheduled on October 21 and March 17— which is when the MS/HS conference comp days are scheduled. Likewise, the middle school PD days could be scheduled on elementary first and third trimester recording/reporting days- November 4 and 17. Please see the attached draft calendar.

Please note the following proposals for the 2017-2018 District Calendar:

- Continue with a week between the new staff orientation and the beginning school date to allow new staff time to assimilate information.
- Since construction will no longer necessitate staff not being in the buildings, move the district PD date to the day after Labor Day, which was in place 2014-2014.
- August 16 would be the first day for grades 1-5, and grade 6 would attend a half-day at MS. Grade 9 would attend a half-day at HS. August 17 would then be the first date for all students in grades 1-12 to attend.
- During MS/HS conference comp dates on October 20 and March 16, elementary PD will take place.
- During elementary conference comp day on November 10, MS PD will take place. -During elementary conference comp day on February 23, both MS and HS PD will take place.
- Spring break coincides with KU's spring break.
- An inclement weather day is scheduled for April 20.
- The last teacher day is scheduled on May 25, before Memorial Day.
